## **COMMITTEE CHARGES**

1. Education (Learn It): Enhance and expand integrated offerings and distribution of SCCM educational programs.

Fundamentals Leadership	The charge of this committee is to serve as the umbrella committee for the various Fundamentals committees. This committee serves as the first-line strategic review for potential new Fundamentals content along with optimized information sharing among the Fundamentals committees for business line brand consistency and uniformity.
FCCS: Program	Develops adult program content using a variety of learning modalities to provide basic critical care training to non-critical care special prior to the patient's transfer to an ICU or until the arrival of a critical care specialist.
FCCS: Pediatrics	Develops pediatric program content using a variety of learning modalities to provide basic critical care training to non-critical care specialists prior to the pediatric patient's transfer to an ICU or until the arrival of a pediatric critical care specialist.
FCCS: Crisis Management	Develops program content using a variety of learning modalities to provide basic disaster management training to those who may need to triage and care for victims of disasters or other events that limit available critical care resources or personnel. The committee serves as SCCM's main resource for disaster medicine, providing a pool of expertise to build on existing educational activities, collaboration and just-in-time clinical care when needed. The committee serves as the clearinghouse for disaster-related content distributed through Society channels.
FCCS: Obstetrics	Develops program content using a variety of learning modalities to provide basic critical care training in caring for critically ill and injurobstetric patients.
FCCS: Surgical	Develops program content using a variety of learning modalities to prepare nonsurgical providers for the initial care, stabilization, and urgent disposition of seriously ill surgical patients. Content will expand on surgical topics touched upon or not covered in the FCCS course, and format and delivery of materials will align with other Fundamentals courses.
FCCS: Resource Limited	Develops program content using a variety of learning modalities to prepare nonintensivists and interprofessional providers to treat the critically ill and injured patients they encounter in austere environments where availability of resources may be limited.
Graduate and Resident Education	Seeks to improve graduate and resident education in critical care and to foster an interest in critical care among trainees. Develops a maintains VCCRII course content for adult residents rotating through the ICU as well as other tools that foster trainee learning.
Undergraduate Education	Seeks to improve undergraduate student education in critical care and to foster an interest in critical care among students. Develops and maintains VCCR I Adult course content for students as well as other tools that foster student learning.

COMMITTEE CHARGES	
On-line Module Development Committee, Pediatrics	Identifies topics, develops and maintains content, and recruits authors if necessary for two distinct series of pediatric critical care online education modules: one series for medical students and a second series for residents (PVCCRI & PVCCRII). Ensures that all modules conform to design and content quality standards. Monitors learner feedback and revises modules as needed to ensure the educational efficacy of each module.
Critical Care Essentials Task Force	Develops program content using a variety of learning modalities to provide education to non-intensivists who routinely manage critically ill patients.
Quick Study Advisory Workgroup	The Critical Care Quick Study Advisory Workgroup will review and approve content for the Critical Care Quick Study program that is submitted to the online portal. Content will be solicited by SCCM staff from members and non-members involved in medical education and other areas and be focused on the acquisition of short, readily accessible content for use both by experienced clinicians and trainees. Workgroup members will regularly review and approve content submitted via the Quick Study portal and once approved, this content will be housed online in SCCM's LearnICU knowledge base and tagged as Quick Study format and made accessible through t SCCM content app. Annually the Advisory Workgroup will also select top content accepted that year to be highlighted at the SCCM annual Critical Care Congress, for which certificates will be given during the Congress abstract awards ceremony. Workgroup members agree to decline reviews submitted by individuals from their institution or place of employment to avoid any potential conflicts of interest
Patient Management During Disasters Program Task Force (CDC)	Develop free online education addressing patient management during infectious disease outbreaks and natural disasters across the continuum of care, including acute pre-hospital care, emergency medicine, and intensive care.
Review and Assessment: Encourage health Review and Assessment Management	Oversees the strategic direction of the board preparation business line, ensuring consistency across all products in the line, ensuring they meet board standards, creating universal blueprints, and developing additional assessment products.
Item Writing, Adult	The committee is charged with test question development. Each member is expected to construct high quality multiple-choice question aligned with the examination blueprints, each with supporting references. Each committee member is responsible for: attending item writing training classes provided by SCCM and writing 1–2 questions monthly with referenced rationales and submitting them to SCCM headquarters.
Item Writing, Pediatrics	The committee is charged with test question development. The is delivered online with pre- and post-tests, offers small study groups, and provides handouts to assist learners in enhancing their knowledge.
Echocardiography Review Course	Develops a comprehensive echocardiography/ultrasonography review and update course on the use of ultrasound on patients. The course targets all members of the critical care team and prepares individuals for various examinations leading to certification in the area. The course is delivered in person and online and includes various supporting materials to assist learners in enhancing their knowledge in the field.

Congress Program Committee	Develops a continuing education program and forum to present the latest research for the dissemination of high-quality critical call information through excellent speakers and recognized experts. The program is formulated by using the multiprofessional care mestablished by the Society, and encourages high engagement by Congress Attendees. While the committee is responsible for the annual Congress, the committee shall also develop complementary programming to extend the learning experience throughout the

Immigrant Critical Care Professionals (ICCP) Mentoring Task Froce	Develop and implement a mentorship pilot program for leadership-building for ICCPs, to encourage their professional development and inclusion both within the Society and the broader external healthcare community.
ICU Design Award Committee	Selects the facility that promotes the creation of an ICU that combines humanitarian patient care and functional design for this annual award. Submits proposals every three years for the American Institute of Architects Academy of Architecture for Health (AIA/AAH) guidelines for design and construction of hospital and healthcare facilities. The committee is composed of members of SCCM, American Association of Critical-Care Nurses, and AIA/AAH.
Norma J. Shoemaker Award	Selects the recipient of the award that honors an SCCM nurse member for excellence in critical care clinical nursing practice, education, and/or administration.
Safar Global Partner Award	Awarded annually to an individual, hospital, or organization that expands the reach of SCCM around the globe.
Diversity, Equity and Inclusion	The Diversity and Inclusion Committee is charged with:  1) Analyzing diversity data from SCCM committees, workgroups, leadership, faculty, and authors  2) Working with these groups to raise awareness of the benefits of increased diversity  3) Encouraging the participation of underrepresented populations in SCCM activities and mentoring these populations  4) Identifying opportunities for increasing the diversity profile  5) Promoting SCCM's value and seeking of diversity and inclusive practices within the critical care profession and within the SCCM organization.
Program Improvement Workgroup	Evaluates various aspects of SCCM programs and services (both content and delivery) to improve their quality and usefulness.

American College of Critical Care Medicine	Fosters the highest goals of multiprofessional critical care by honoring individuals whose achievements and contributions demonstrate personal commitment to these goals. Develops guidelines and practice parameters.
Audit Committee	Makes recommendations to Council on the selection of independent CPAs. Negotiates on behalf of Council the compensation of the independent CPA. Confers with the auditor to satisfy committee members that the financial affairs of the Society are in order. Review the audit and recommends acceptance to Council.

Strategic Planning Management Committee	Facilitates the management of the Society's overall planning process; solicits proposals that advance the goals and reviews current activities for alignment.
